

**NOTICE OF PUBLIC HEARING ON PETITION FOR INCORPORATION
OF THE CITY OF STILWELL IN JOHNSON COUNTY, KANSAS**

On February 4, 2008, a petition was filed with the County Clerk of Johnson County pursuant to K.S.A. 15-116 requesting that the area generally known as the remaining unincorporated portion of Oxford Township in Section 17, Township 14S, and Range 25E, and the unincorporated portion of Aubry Township east of Antioch Road, be incorporated as the City of Stilwell in Johnson County, Kansas. The County Clerk has determined that the petition, as filed, was in proper form and did satisfy the necessary statutory requirements and has presented the petition to the Board of County Commissioners of Johnson County, Kansas for its consideration.

You are hereby notified that the Board of County Commissioners of Johnson County, Kansas shall hold a public hearing on the petition for incorporation of the City of Stilwell in Johnson County, Kansas on Monday, April 14, 2008, at 7:00 p.m. at the Blue Valley High School Gymnasium, 6001 West 159th Street, Stilwell, Kansas. The hearing shall convene as scheduled on April 14, 2008, but may be adjourned and reconvened thereafter from time to time as necessary and advisable for a full hearing and consideration on the petition for incorporation. The scope of the public hearing on Monday, April 14, 2008 shall be modified to exclude that portion of the proposed incorporation area lying west of U.S. 69 Highway that was the subject of the recent annexation by the City of Overland Park, that annexed said area into the city limits of Overland Park, Kansas. All persons residing within the area described in the petition, all owners of property within the area, and all persons, agencies, and representatives of governmental units notified pursuant to K.S.A. 15-119 shall be entitled to be heard and to present documentary evidence and briefs. 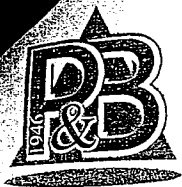


LEGAL DESCRIPTION

All that part of the AUBRY and OXFORD TOWNSHIPS in Johnson County, Kansas, more particularly described as follows:

Beginning at the Southeast corner of Fractional Section 14, T15S, R25E of the Sixth Principal Meridian, Johnson County, Kansas; thence West, along the South lines of Sections 14, 15, 16, 17, and 18, T15S, R25E of the Sixth Principal Meridian, Johnson County, Kansas, to the Southwest corner of said Section 18; thence North, along the West lines of Sections 18, 7, and 6, T15S, R25E of the Sixth Principal Meridian, Johnson County, Kansas, to the Northwest corner of said Section 6, said point also being the Southwest corner of Section 31, T14S, R25E of the Sixth Principal Meridian, Johnson County, Kansas; thence continuing North, along the West line of said Section 31, to the Northwest corner of said Section 31; thence East, along the North line of said Section 31, to the Northeast corner of said Section 31, said point also being the Southwest corner of Section 29, T14S, R25E of the Sixth Principal Meridian, Johnson County, Kansas; thence Northerly, along the Westerly side of Sections 29 and 20, T14S, R25E of the Sixth Principal Meridian, Johnson County, Kansas, lying easterly of Metcalf Avenue, as now established, to the Northwest corner of said Section 20, said point also being the Southwest corner of Section 17, T14S, R25E of the Sixth Principal Meridian, Johnson County, Kansas; thence North, along the West line of said Section 17; to the Southwest corner of the NW¼ of said Section 17; thence East, along the South line of said NW¼, and along the North lines of Lots 111, 110, 109, 108, 107, 106, 105, and 102, BLUE VALLEY RIDING, a subdivision in Johnson County, Kansas, and their extensions thereof, to the Northeast corner of said Lot 102, said point also being the Southwest corner of Lot 43, BLUE VALLEY RIDING, said point also being the Southwest corner of the East ½ of said NW¼; thence North, along the West line of the East ½ of said NW¼ and along the West line of Lots 43, 42, 41, 40, 39, 38, 37, 36, 35, 34, 33, 32, 31, 30, 29, 28, and 27, BLUE VALLEY RIDING, and their extensions thereof, to the Northwest corner of the East ½ of said NW¼; thence East, along the North line of said Section 17, to the Northeast corner of said Section 17; thence South, along the East line of said Section 17, to the Southeast corner of said Section 17, said point also being the Northwest corner of Section 21, T14S, R25E of the Sixth Principal Meridian, Johnson County, Kansas; thence East, along the North lines of Sections 21, 22, and Fractional Section 23, T14S, R25E of the Sixth Principal Meridian, Johnson County, Kansas, to the Northeast corner of said Fractional Section 23; thence South, along the East lines of Fractional Sections 23, 26, and 35, T14E, R25S of the Sixth Principal Meridian, Johnson County, Kansas, to the Southeast corner of said Fractional Section 35, said point also being the Northeast corner of Fractional Section 2, T15E, R25S of the Sixth Principal Meridian, Johnson County, Kansas; thence South, along the East lines of Fractional Sections 2, 11, and 14, T15E, R25S of the Sixth Principal Meridian, Johnson County, Kansas, to the Point of Beginning.

The above legal description is for the area to be incorporated as the City of Stilwell, Johnson County, Kansas.
